Warranty Exclusions

- 1. Wear and tear associated from normal use;
- 2. Damage caused to the product(s) by you or any non-authorized third-party;
- 3. Damage caused by acts of nature, abnormal mechanical or environmental condition, modification, abuse, accident, disassembly, misapplication, neglect, or abnormal use conditions:
- 4. Damage by unauthorized repair.
- 5. Products with modification to the serial number or manufacturer identification label(s) or sticker(s), whether removed, falsified, damaged, altered, or made illegible;
- 6. Damage caused by improper assembly, handling, installation, or operation; including any use not in accordance with any supplied product instructions;
- Damage caused by an external electrical fault or by connection to an improper voltage supply;
- 8. Removal or reassembly of heat spreader;
- 9. Missing, damaged, detached, eroded, or bent contact pins, chips, parts, casing, connectors, or heat spreader;
